# COMMITTEE REPORTS:

## Status of Roads following flood.

John Finch reported the following: Emergency Services set up a command center at the Five Mile Point Fire Station and were here to help put out cones and barrels and emergency work was done by ZMK on Brink Road and Blakesley Road, which are no longer emergencies. The ditches on Blakesley were about six feet deep in some locations. We have gone through almost 200 loads of shock rock from the Broome County Landfill, which is free to the Town with free delivery included. Different municipalities in the county also helped out. Dan Griffiths of Griffiths Engineering and Emergency Services went to marked locations and did an assessment of the damage to the roads and based on Dan's assessment we have about \$1.5 million worth of damage throughout the Town. That assessment does not include Pope's Ravine which is about another \$900,000 which increases the total to almost \$2.5 million worth of damage. 600 tons of the cold mix that was put down on the roads a week before the storm lifted up and peeled off into yards and ditches. Today Suit-Kote milled the worst parts of Gorman Road. Hopefully they will be paving again Thursday and Friday and finishing Grange Hall. There are many other places in the Town with a lot of damage and the nine miles of road need to be oiled, stoned and sealed before winter or the money already spent on those roads will be wasted, they are still our priority roads. Once that's done, work will start on other locations in the town and hopefully we will get some assistance to start getting contractors to help out. The entire bank by the bridge on Foley Road washed right out and that's a job the town can't handle alone. Most of the pipes that were plugged have been cleaned out but complaints are still coming in.

#### Water Issue.

Councilman Grubham questioned the status of the discolored water issue. John Finch said testing showed iron and manganese were slightly elevated but not to the extent that it would cause any discoloration. He said the Water Department flushed the lines again on the south end of Town and the day after they were flushed Rod Hoover had the same discoloration issue when he filled his tanker that he had before. He said we are still trying to figure it out, adding that there is no elevated copper either. John said the Health Department saw the test results and said the water is safe to drink. He said possibly the lines should be flushed harder or longer, which they will try, noting this just started last year. Councilman Grubham asked if there is anyone else that can be brought in to take a look at it. John said we are looking at the air stripper to make sure there is nothing going

on there. Councilman Grubham wants to be sure that we still look into this and try to get an answer and John said they will keep working on it.
