#### Discussion – M. Latini

Councilman Weingartner read the original resolution for Marc Latini from the August 2019 board meeting. He suggested that Marc may no longer be provisional and this new resolution #15 is making him permanent. Mr. McKertich questioned the wording of provisional over probationary in the original resolution. Councilman Diffendorf asked if he had to take the civil service test. Mr. McKertich responded that is what would make it provisional over probationary. Supervisor Kniffen said he must have taken the test the way it's worded on the new resolution but let's wait to be sure. Councilman Weingartner said he can check with Mary Kay.

### Discussion - Parks

Councilwoman Legg inquired about the status of park pavilion rentals. Councilman Grubham explained that 50 people are allowed to gather, so we've set it up that pavilions #1 and #3 at Veteran's River Park, and Grange Hall Road and Valley Park pavilions will be rented. Just enough tables have been added for 50 people to use so guidelines are followed. A stipulation has been added stating the permit holder will abide by the guidelines, but we won't be policing it, they are responsible to do that. Councilman Grubham said he did talk to the county and they are not policing pavilion groups either.

Councilman Grubham also mentioned that people now have interest in the ball fields and a big tournament we normally have here has moved to Scranton because the Governor made it too hard for them to do it. We still have the YMCA, a senior group, and a church group

and we may be using one of the fields for baseball but that's iffy. Councilwoman Legg asked if the Town website will be changed because it currently says there is no pavilion use. Town Clerk Kelley Diffendorf responded that she and Mary Kay had changed it to 50 people. Councilman Weingartner said he has recently had trouble with the website. Councilman Grubham said we have a new website being developed and it should accommodate all the information we haven't been able to put on there now but there have been issues lately, hopefully within a couple of months it will be complete.

### **Discussion - Zoning**

Supervisor Kniffen asked Mr. French from the public if he had something to discuss. Code Enforcement Officer Chad Moran said Mr. French was supposed to submit a change of zoning form but he didn't get the form in so it wasn't on the agenda. Mr. French said it was his first time at a meeting and would like to see how it goes. Supervisor Kniffen asked if he wanted to request a change in zoning. Mr. French replied that he did on a property on Foley Road. Supervisor Kniffen asked about the procedure for this. Chad reiterated that Mr. French has the forms and needs to fill them out, all the information is on the forms.
