OTHER - Broome County Budget Address.

Brian Norris, Director of Broome County Security, spoke to the Board on behalf of the Broome County Executive's Office regarding the 2023 Broome County Budget Address. Mr. Norris hit on key points throughout his speech that included, the growth of the fund balance to \$35 million, tax cuts, the return of major businesses and projects to the area, how the American Rescue Plan fund is being utilized, new service to the Binghamton Airport, affordable housing, the repair of roads, parks improvement projects, Veterans funds, small community fund, public safety, crime rates being down, and much more. Mr. Norris thanked everyone for their time and took a few questions.

After hearing questions and comments from the Board and residents, Mr. Norris acknowledged that all the questions and concerns would be passed on to the Broome County Executive's Office. A brief description of the comments and questions mentioned are as follows: the fund balance and how high it can go (Councilman Diffendorf), will the moratorium on gas prices end or be extended (Marchie Diffendorf), any improvement to the parking at Bagsai (Marchie Diffendorf), Hawkins Pond renovation needed (Carolyn Price), possible increase of tax rates depending on equalization rates (Carolyn Price).

DISCUSSION - Truck #24 and Truck #26.

John Finch reiterated the discussion he had at the work session regarding the preauthorization to order new Ford trucks (#24 and #26). With Ford being so backed up and not sure if the orders will even be processed John Finch has been looking at other avenues to upgrade these two trucks. At this point, the plan for Truck #24 has not changed and John Finch is hoping to get definite numbers from Ford soon on how much a new one would cost. Regarding Truck #26, he found a 2019 Ford F-550 on the auction site that comes fully equipped with more options than our current truck and its in very good shape. The auction ends next Wednesday (11/9/22) at 6 PM. John Finch is asking the Board for approval to go out to bid on this vehicle (an undisclosed amount was given to the Board regarding the max amount to bid). Councilman Diffendorf question John Finch if he was going to come back to the Board in two years to get another new truck since this one is only two years older than the current truck. John Finch claimed that he would not have to because of the stainless steel box, aluminum cab, versatility of the live floor, and good maintenance. If this bid does not go through then the plan is to go back to the option of ordering the truck through Ford.

When selling the current Truck #26 John Finch is speculating it should bring in \$40,000 or more.

Councilwoman Legg moved to adopt resolution authorizing the Commissioner of Public Works to bid on a 2019 Ford F-550 XL Super Dump Truck and Plow with the purchase price to be approved in a subsequent resolution. Councilman Weingartner seconded.

The hope is the project will start in the spring/summer of next year.
