# **October 3, 2023**

A regular meeting of the Kirkwood Town Board was held on October 3, 2023 at 6 PM at the Joseph A. Griffin Town Hall with Supervisor Lewis Grubham presiding.

# **PUBLIC PARTICIPATION:**

Lisa Batzel of William Street told the Board she was disappointed in the vote at the last Town Board meeting on sending the warehouse project of the Five Mile Point Racetrack site to the Planning Board for review.

Lisa Batzel also spoke to the Board about a water issue she is currently dealing with, and has been dealing with for a long time. She has black debris in her water and has to change the filter on her tankless water heater every two months instead of every six months as recommended. She reminded the Board that she has complained about this in the past and the head of the Water department has told her there is nothing that can be done. She showed the Board pictures from her phone of the black debris. Lisa Batzel expressed that something needs to be done about the water in the Town because it is ruining things, she gave several examples of items in her home that have been ruined. When she first moved to her house it was not like this, and the debris does lighten up when the hydrants get flushed. John Finch reported that the Water department is looking into other filtration options. He said the black debris is manganese. The Water department will be scheduling hydrant flushing on a bi-annual basis. Supervisor Grubham said it will be looked into.

Angela Tokos of Haskins Road referenced a correspondence she had sent to Supervisor Grubham regarding the Warehouse Project/Five Mile Point Racetrack site and was hoping to get some answers at the meeting. She had reviewed the traffic report and noted that 272 trucks could possibly be entering and exiting the site daily during two separate work shifts, but was concerned if a third shift was added what that would do to the traffic numbers since Mr. Meinstein did not rule that option out. After speaking with NYSDOT regarding additional shifts, the takeaway was the data should be updated to reflect such possibilities and that it was incumbent on the County and the Town to ensure that happens. Angela Tokos asked the Board if this would be done. Supervisor Grubham explained that Mr. Meinstein has not turned in any further information at this point, so nothing has been sent to the Planning Board yet, which means there is nothing to update at this point. The earliest this could go to the Planning Board is November. If this does move forward, all information will be made available.

Angela Tokos continued with questions about truck routes and the legality of light industrial use with certain stipulations by Mr. Meinstien. Supervisor Grubam reiterated that the only thing that has been asked was the property be rezoned. No other information has been presented to us and these questions just can't be answered at this time. Angela Tokos noted that she is hopeful that before the project moves any further that some of these questions can be answered for the community. Supervisor Grubham assured her that will happen.

# **October 3, 2023**

Marchie Diffendorf of Gorman Road explained that he noticed the Purple Heart sign at Veterans River Park was broken, so he talked to Glenn Robbins of Robbins Sign Company, as well as Supervisor Grubham about getting it replaced. He presented pictures to the Board of the existing sign and the proposed sign, stating the new sign has a cleaned-up look. Marchie Diffendorf asked the Board to approve this new sign tonight, and Robbins Signs has agreed to donate the new sign and installation at no cost. He would like to have it up in time for the Veterans Day ceremony. Councilmember Legg thanked Marchie Diffendorf for taking time to do this, as well as maintaining the welcome sign at Exit 1.

**COMMUNICATIONS:** Letter from NYSDOT, Letter from ACHIEVE, and Resignation Letter from Edward Shoemaker

**Discussion.** Councilmember Diffendorf commented on the letter from NYSDOT regarding the paving of Route 11, stating unfortunately we are not being treated very well on this end of the county. The western end, Vestal/JC mall area, seems to get paved every three years. We can't get them to pave here, they patch, so we have a rough ride, no shoulders, and can't get a guardrail fixed and that seems to be acceptable to New York State. Supervisor Grubham explained he sends letters every year, and gets the same response every time. He has made several attempts to get the guardrail fixed at the intersection near Valley Park, to no avail. Also noting, the portion of I86 in Kirkwood is the worst piece of road in Broome County. He will continue to call and send letters.

#### **COMMITTEE REPORTS:**

# Paws for a Cause - Humane Society.

Councilmember Wasson reported the Humane Society held their Paws for a Cause fundraiser at Veterans River Park this past weekend, it was very successful and they would like to do it again next year.

# **Broome County Transit Committee.**

Supervisor Grubham reiterated what Councilmember Diffendorf stated regarding the lack of paving from NYSDOT. Also mentioning he is on the Broome County Transit Committee (made up of County and DOT officials) and when questioned about paving our roads it gets ignored and the meeting continues. It's very difficult. Supervisor Grubham gave an example of how it cost 25 million to pave a walkway on the Vestal Parkway, but they can't find money to pave the roads in Kirkwood.

#### **Meters Installed.**

John Finch reported that approximately 860 meters have been installed with 322 left to still be installed. Sue Glovich has been calling residents and sending letters to get people signed up for appointments, she is doing a great job.

# **MEO Heavy – New Hire.**

John Finch would like hire someone to replace Ed Shoemaker who is retiring at the end of October. He would like to start interviews the week of October 16<sup>th</sup>. Councilmember Diffendorf and Councilmember Wasson agreed to interview applicants.
