Dog Control Report.

Councilwoman Legg reported numbers from the January 2023 Dog Control Report. A copy is filed in the Town Clerk's office.

Black Top Hot Box.

John Finch spoke to the Board and referred to the brand new 4-ton Hot Box he was interested in purchasing at the work session last week and reported upon further review that size hot box was too large for the F550 truck to pull, so that has been removed from the agenda. Therefore, he asked for the Boards approval to bid up to \$9,000 (that includes buyer's premium percentage) on a used 2012 KM International 2-ton Hot Box from Auctions International. This unit is said to be fully operational.

Water Break on Route 11.

John Finch explained there was a water break over the weekend, south of Studer's Garage on the left-hand side. It was a service line that went under the road to an empty lot. It had to be dug up Sunday night because the south end of town started getting brown water, the Highway department was able to take care of the situation by turning the corporation stop off. These water breaks appear to be an ongoing problem with many of the copper lines running under Route 11, all towards the south end of town and all installed after the extension of the water main.

2023 Projects.

Supervisor Grubham referenced a handout with maintenance projects that are set to be completed this summer at River Park, Valley Park, and the Town Hall. They will be covered by fund balance and reserve funds. It was noted it has been 30-40 years since work has been done on the Town Hall.

ARPA Stimulus Money.

Supervisor Grubham reminded the Board that the Town initially received \$562,000 in stimulus funds with almost \$400,000 remaining. Industrial Park Sewer Project, a pump for the main sewer station, and soft starts for Sunset Drive and Kirkwood Avenue pump stations have been deducted from the initial amount. There are two projects in the works, Upper Court Street Sewer Line Project and the Stratmill Road Water Tank Rehabilitation Project, with bid amounts pending. After estimated costs on those projects it is hopeful there will be enough left to complete other needed projects.
